**RQMF Disciplinary Procedures.** All memorial masonry companies and registered fixers wishing to participate in the RQMF must sign an undertaking to abide by the decisions of any independent disciplinary committee formed to rule on an alleged breach of fixing standards made against them.

**Data Protection Act 1998.** The personal information provided above will be treated in strict accordance with the Data Protection Act 1998. You must consent to the personal and business information being published on the National Association of Memorial Masons Register of Qualified Memorial Fixers and acknowledge that the information will freely available to those accessing the database on the NAMM RQMF website for the purposes of confirming the credibility of both your company and those employed within it. You have the right to access the information at any time and request that any factually incorrect errors be corrected. You may ask at anytime to have your information removed from the database.
